Includes documents advocating use of recoverable rocket boosters instead of expendable rocket boosters, documents advocating a western launch site over Kennedy Space Center, the bill from the 1971 Utah State Legislature creating the Utah Spaceport Committee, meeting minutes and agendas from the Spaceport Committee, news releases and newspaper clippings related to the Spaceport Committee and space shuttle development, studies from the Spaceport Committee detailing advantages of a space shuttle launch site in Utah.
