The Planning Board, through Advisory Commission secretary and planning board director, Sumner Margetts, worked to select, acquire, and develop the site for the new State Prison. The prison at Sugarhouse was to be relocated and the new site was to be chosen by the committee. Reports were made of problems pertaining to the disposition of land in the Sugarhouse site and the marketability of the area. The commission studied such items as land ownership, water supply, quality of soil, and obtaining rights-of-way. This series contains petitions for consideration by landowners willing to sell their lands; maps of the areas under consideration; some photos of the areas; reports on prison conditions; reports detailing the decisions surrounding the choice of the point-of-the-mountain site; a report on the necessity to move the Sugarhouse prison to a new site; and studies of prison labor problems.

Included in this series are studies conducted by the Agricultural Adjustment Administration; analysis of agricultural resources and possible resettlement areas; land classification reports; farm tenancy reports; elevation studies; information on western state land boards; surveys of agricultural cooperation and the dairy industry; range land studies; hearings in interstate cooperation; and the Utah Conservation and Research Foundation incorporation proposal and conclusions.

The Community Improvement Appraisal Committee, originally under the jurisdiction of the planning board, came under the joint direction of the board and the Public Works Administration. Sumner Margetts, the acting chairman of the Utah State Planning Board, was one of its members. The committee's purpose was to evaluate the effectiveness of federal relief programs throughout the state. Concerned that federal aid might be detrimental to morale or public enterprise, the committee generated statistics and requested reports from sources outside of the Works Progress Administration (WPA) or the Public Works Administration (PWA). These records include the committee minutes, reports created by the committee, reports received from individual municipalities and countries, and correspondence.

These health related studies were prepared by or for the Utah State Planning Board, 1934-1941. One of the State Planning Board's responsibilities was to study the problems and develop plans for health facilities, medical services, sanitation, and disease control. The board collected the following data and surveys included in this series: A Civil Works Administration sanitary survey; a survey of the Utah State Mental Hospital; a public nursing report; mortality statistics; a survey of hospital facilities; a survey of Utah's mental health facilities; a lengthy report of the health conditions and facilities in Utah; health policies; and an analysis of the spread of tuberculosis. Also included are reports made by the State Health Department which were created while preparing a health survey. This survey covered such topics as laws, diseases, plagues, registered doctors and dentists, child welfare, expenditures on health, and sanitation problems.

Reports on the following subjects are included in this series: beet sugar industry, cheese making, tanning hides, salt production, wine production, honey production, commodities, in general, cooperative marketing, cost of living and wage, economic activities, and resources, income and debt, labor groups, livestock, payroll, commercial trade, land leases, real estate, trade restrictions, industrial movements, worker's compensation, railroad freight weights, and man hour reduction.

Under the direction of the State Planning Board and with the assistance of the Works Progress Administration, a statistical survey of industrial trends was made for eleven western states. The purpose of this survey was to collect the basic materials necessary to make a comparison of Utah's industrial position in the economy of the region with that of the other states and to compare the trends in industrial growth. This study was valuable in determining factors responsible in part for the population movements within the region, net migration from the state, and other problems of interest. Included are basic compilations for agriculture, livestock, manufacturing, and minerals. Following those is a tabulation of the total study. They made a special report on Carbon County which records population, employment, agriculture, mining, manufacturing, education, and other public resources. There are also studies on domestic and foreign corporations, percentages of forest land in the state, and mortgages in Utah.

DESCRIPTION:

The Federal Emergency Relief Administration Division of Research and Statistics worked in conjunction with the State Planning Board to create this research study. Its purpose was to measure the losses to insurance policy holders and to identify the remedies for conditions which permitted such losses. This series includes a brief outline of the proposed study, a brief survey of selected towns divided into income groups, and analyses of distributions for policies lapsed and in force.

The Planning Board and Soil Conservation Committee prepared and submitted reports at these hearings that contained data on drainage irrigated lands, precipitation, run-off, area by elevation, population, economic conditions, agriculture, mining, manufacturing, retail trade, assessed valuation, and summaries of proposed reservoir sites; they organized soil conservation districts; and presented detailed reports of flood conditions on the streams of the Great Basin in Utah. DESCRIPTION:

These are reports of the Great Salt Lake diking project, 1932 to 1937, made by the State Planning Board members and consulting engineers. The proposed plan was to dike sections of the Great Salt Lake on the northern and eastern sides of Antelope Island to allow the Weber River and the Jordan River to create a fresh water reservoir. The purpose of this reservoir was to supply water for industrial, agricultural, and recreational uses but the plan was found to be too costly and impractical due to the salinity of the water. Included in this series are preliminary reports, meeting transcripts, investigations of technical problems, maps, cost estimates of hydroelectric power, cost estimates of pumping water, and studies of water levels and water storage capacities.

The National Resources Committee, divided into drainage basin committees, held meetings concerning water reclamation for the Bonneville Basin, the Colorado River Basin, joint meeting involving both these, the Lahontan Basin, and the Great Salt Lake Basin. The Uintah Basin and the water storage meetings were held on the state level, independent of the National Resources Committee. The National Reclamation Association minutes is a transcript of a national convention involving the State Planning Board. These minutes contain lists of attendees and their positions, updates from various federal and state agencies of their programs and progress, statistics, and discussions of issues.

The water resources division of the State Planning Board collected the various reports contained in this series. The State Planning Board actively cooperated with federal, state, and local agencies for the development and conservation of water resources. Early in the development of state planning, these agencies began their studies by gathering data on a wide range of water resources subjects. Included are efficiency studies which measure water evaporation and supply forecasts; federal plans created by the National Resources Committee, the Federal Emergency Relief Administration, the Bureau of Reclamations, and other agencies; studies and data concerning the Great Salt Lake; ground water studies of the Salt Lake, Sanpete, and Woods Cross areas; precipitation studies; proposed projects including the Lawrence Dam, the Provo River, the Vernon and Widstoe additions, the Bingham - Tooele tunnel, and power sites; reports on projects then under construction; reservoir studies, river basin surveys such as the Sevier, Great Salt Lake, Uintah, San Juan, and Fremont drainage areas; sewage control data; underwater regulations; Utah Lake studies; and Utah County water rights decrees. Many of these reports include maps of the areas under study.
