It includes the names of alleged victims and perpetrators of child sexual abuse cases, demographic data on both the alleged victims and perpetrators, outcome data on both the treatment of the victims, and suspect(s)(charges filed, pleas entered, jury verdicts, and sentencing). The database is backed up weekly to tape using Cheyenne Arc Serve Version 6.0 for Windows NT. Only statistical reports are printed.
